


For each Strategic Objective, the Strategic Plan has a list of goals. These are measurable outcomes that each department has to report back on to Chiefs & Council.

And this is some of the work we are doing . . .

- done a number presentations and field trips to share cultural information with XCS, Signal Hill, and Ts'zil students and staff
- ♦ We are working with the Province and Coast to Cascade Grizzly Bear Initiative to improve access management in the Upper Lillooet to \blacklozenge protect Grizzly Bear habitat
- We expanded our catch monitoring of sockeye due to the low numbers of returning sockeye collected from our fisheries pro-
- In August we made an announcement to the community about the low salmon return (thank you for your support to reduce your catch!)
- We recently finalized an agree- ♦ ment-in-principle with Whistler Blackcomb, the Province and Squamish Nation to address Lil'wat title and rights at Whistler

- Our Cultural Technicians have ♦ 17 on-call staff were employed by us over the summer and fall to carry out fisheries, archaeological and environmental field work
 - We completed 14 new archaeological field assessments this last field season
 - Carbon-dating work was conducted at s7istken sites at Sampson Creek and Eddies Lake. Thank you to our volunteer helpers: Patrick Dolan, Kristi Bowie, Hiroko Pascal, Talon Pascal, Kiki Pascal, Jeremy Dan and Laytin Williams
 - We are uploading our traditional use and cultural studies into a web-based data system that will be accessible for community members to log in and access. (stay tuned)
 - We are in the process of recording and mapping all known cultural sites on reserves lands to ensure their long term protection.
